Dear Dr. Wheelan,

Texas A&M University-Commerce has received approval from The Texas A&M University System Board of Regents to offer the existing **Doctor of Education (EDD) degree program in Supervision, Curriculum, and Instruction** via distance education at the Commerce Metroplex Facility in Mesquite, Texas, and in the Rockwall Independent School District in Rockwall, Texas. The university anticipates meeting a need for doctoral studies for aspiring teachers and public school administrators in one of the fastest-growing populations in the United States, the Dallas/Fort Worth Metroplex.

All of the courses in this program currently exist, and existing faculty members teach in face-to-face formats, web-enhanced, and online (currently fewer than 50 percent). The current delivery system is the same except for adding the two face-to-face locations. Both the Mesquite facility and the Rockwall facility are SACSCOC-approved sites for master's degree programs currently being delivered there. In addition, a university library is located at the Mesquite site. A&M-Commerce certifies that the existing EDD program to be offered at these two sites meets the standards and criteria established in the Texas Admin. Code, Chapter 4, Subchapter P, regarding the approval of distance education courses and programs for public institutions by the Texas Higher Education Coordinating Board.

A&M-Commerce does not believe that this program "is a significant modification or expansion of the nature and scope" of the institution, so is submitting this notification letter only. Please advise if any additional information or a substantive change prospectus is required. A Substantive Change cover sheet is attached. The effective date is the Fall Semester 2012.
