### Course Development:

#### **SWK 597 Social Work in Healthcare**

*Developed this course as a summer elective to provide student with a solid foundation of policy, benefits, and case management in modern healthcare.*

**SWK 595 Research Literature and Techniques** – *advanced the curriculum of this course to teach students data analysis specific to evaluate program and practice using EXCEL. This was developed in response to needs in practice settings when social workers do not have access to statistical packages such as SPSS. Developed the entire curriculum to be taught using Microsoft EXCEL*

#### **SWK 497/597 Social Work in Costa Rica; Cuba**

*In 2012 created the first Faculty-Led Study abroad program for the School of Social Work and one of the first for A&M Commerce. In 2013, the inaugural class of 11 MSW students for study abroad in Costa Rica. Since the first class, have traveled one-two times per year for study abroad to Costa Rica through 2019 with travel interrupted in 2020 due to the pandemic. Because our study abroad program is a standout at A&M Commerce, I was asked by the Director of Global Programs and the Provost for Academic Affairs to create an opportunity in Cuba. I was able to take students to Cuba in Summer of 2016 and Summer 2017 for one of the most amazing experiences. Through the relationships we built in Cuba, we placed a student there to complete a field practicum in Fall 2016 and sponsored a Cuban speaker on women's rights to come and speak at A&M University in Spring 2017.*
