**Course Description:** The course will cover the techniques and skills necessary in scenic painting. Topics include: terminology, tools, faux finishes, abstract techniques, realistic reproduction, as well as washes and glazes.

Upon completion, the student will:

- 1. Know the vocabulary, tools, and techniques of theatrical scene painting.
- 2. Develop speed and accuracy in regards to the replication of textures and images for scenery.
- 3. Work with the tools of scenic painting to create fully-realized images in a variety of styles.
