**Materials – Textbooks, Readings, Supplementary Readings:**

**Textbook(s) Required:** As this is a practical (hands-on course) no text is required.

**Course Description:** The purpose of this course is to learn theatre by doing theatre, in any and all of its aspects (production, rehearsal, and performance). In all cases the particular duties will tie as closely as possible to the production of the shows. When that is not possible, the duties will include routine cleaning and maintenance. We acknowledge that theatre cannot be fully taught in a formal classroom, as every day of every production presents new or unique challenges. The course is therefore about problem solving, skills development, and use of the technology. However, it is also about the more abstract, perhaps more valuable aspects of the theatre, including such things as work ethic, reliability, positive attitude, respect and loyalty to each other and to the production. All of these things must be added to the more traditional values of scholarship, research, and artistic development. All of these things combined are what makes a person a well-rounded and employable theatre professional or teacher.

**Student Learning Outcomes:**

1. Students will learn essential skills (construction, painting, etc.) in the production aspects of Theatre
2. Students will be associated with production crews and the expectations therein
3. Students will be acclimated to proper attitude, skills and decorum required when working in a Theatre environment
4. Student will learn the management and interpersonal skills necessary to attain a leadership position in professional theatre.

## COURSE REQUIREMENTS

### Instructional / Methods / Activities Assessments:

1. The students will arrive everyday (M-R) at 1pm and work on the summer production until 4pm. Attendance will be taken every day, by the professor, to ensure that the students are arriving for every class session, on time.
2. The students *must* be directly involved in the production, performance, design aspects of the show.
3. The students will be evaluated on work performed, attitude, as well as evaluations by the director and instructor.
4. The students will be evaluated on their skill and ability as a leader in theatre production shops or production crew (GRADUATE ONLY).
5. The students are also required to take on a production or performance position in the summer production (GRADUATE ONLY).

### Grading:

Grading is on a point system and is mostly quantitative. This part of the grade is based on accumulation of points. Some points are fixed and obligatory. Others can be accumulated by other means. The point breakdown is as follows:
