MATERIAL

Textbook(s): none required, handouts provided

COURSE DESCRIPTION

Three semester hours. Introduces the basics of horseback riding and horsemanship. Emphasis will be on learning how to care for a horse, tack a horse (English and Western), and basic riding skills. Students will learn how to walk, trot, canter, and jump/ manoeuver small obstacles.

Prerequisites: none

<u>Rationale of the course:</u> The course content enhances students' ability to handle and ride horses. Ideal for students with no or little previous horse experience, students who have not ridden horses for a while, or students seeking to build their confidence handling and riding horses.

STUDENT LEARNING OUTCOMES

- 1. Upon completion of this course, students shall be able to demonstrate knowledge of:
 - a. Handling horses and basic horse care
 - b. Safety standards when around horses
 - c. Appropriate behavior when around horses, especially in a group setting
 - d. Performing specific tasks on the ground and under saddle (walk, trot, canter, obstacles)
 - e. Basic saddling and bridling techniques, English and Western
 - f. Equine health assessment for riding purposes

COURSE REQUIREMENTS

INSTRUCTIONAL METHODS / ACTIVITIES ASSESSMENTS

<u>Student Learning Outcome #1:</u> The student will synthesize knowledge from class discussion, practical learning and supplementary materials.

Assessment Method:

Three exams

Question type: Multiple choice, matching, short-answer, true/ false (50%)

Practical part (50%)

<u>Student Learning Outcome #1b:</u> The student will pass a safety assessment on the first day of class.

Assessment Method:

Safety test after demonstration and class discussion on day 1

Question type: Short answer, multiple choice

100% pass required

There is no minimum skill requirement for beginning horsemanship students. All students should be able to mount and dismount horses by themselves, and have the physical ability to ride for a time period of at least 60 minutes.

Students involved in horsemanship classes will be required to follow all TAMUC rules. These rules are set for the safety of every student and must be followed carefully and stringently. Failure to abide by the rules will result in the student being dismissed from the class. The rules are for the safety of the students, other classmates, staff as well as the horses. Requirements for riding: All students are required to have the following items before they may participate in the riding portion of the horsemanship class (handouts provided on the first day of class):

TAMUC Liability Waiver Forms

TAMUC Equine Center Rules Agreement Form

Proof of Insurance filed with TAMUC, preferred medical services provider

Safety Test passed with 100% (will be kept on file)

Attire: Proper attire is mandatory. Exposed shoulders and shorts are not permitted.

Approved equestrian safety helmet

Jeans/ breeches/ khakis in proper condition (no tears, holes)

Boots (leather, at least up to ankle) with a 1-inch heel

Shirt (button up shirt, or T-Shirt)

Not abiding by these rules will result in sending the student back home and a count for non-attendance for that day. Riders will wear helmets at all times when mounted. Sunscreen protection is strongly encouraged. Students should bring a beverage for rehydration.
