COURSE INFORMATION

Textbook is Optional: A Problem Solving Approach to Mathematics for Elementary Teachers in the 11th edition by Billstein, Libeskind, and Lott.

Course Description: This course is designed for students planning on teaching EC – 8.

Student Learning Outcomes:

- 1. understand numbers, ways of representing numbers, relationships among numbers and number systems,
- 2. understand meanings of operations and how they relate to one another,
- 3. compute fluently and reasonable estimates
- 4. understand patterns, relations and functions
- 5. represent and analyze mathematical situations and structures using algebraic symbols
- 6. use mathematical models to represent and understand quantitative relationships
- 7. analyze change in various contexts

The goal of this course is to develop *understanding* of the mathematics. We are constantly going to be dealing with *WHY* more than *HOW*. As a future teacher you must be able to *explain* mathematics to your students, not just show them how to carry out mathematical procedures. We will focus on underlying structures and development of ideas. In addition, problem solving is a major component of this course. As a future mathematics teacher, you need to become familiar with and skilled in various types of problem solving techniques that are commonly used in mathematical thinking.

COURSE REQUIREMENTS

Grading:

Will be based on a midterm exam, homework and a final exam. In order to successfully mathematically prepare today's children for the technological world they face, a school teacher must have a solid understanding of a broad spectrum of mathematics, including mathematics at a level considerably beyond the grade he/she teaches.

Midterm -	30%
Final –	30%

Make-ups: Make up exams will only be given in the event of an extreme, documented emergency.

Attendance:

Course Specific Procedures:

You will be given homework that will be due approximately two to three times a week online. In addition, your exams will be administered in a face-to-face environment. The times are listed below. <u>If you cannot make these times, you will need to drop this course.</u> The exam will not be given on the Commerce campus.

Midterm:

On June 23rd, you will take the midterm exam from 12:00 pm – 2:00 pm. The exam will be on the Corsicana campus of TAMU-Commerce. The room will be announced at a later date. You will need to bring a photo ID for the testing. Please be on time so that you have the full time for the test. Tests will be taken up at 7:00 regardless of what time you arrive.

Your only other option is to pay to take the exam at a local junior college testing center. The exam will not be given in Commerce and Commerce does not have a testing center for you to use. The closest testing center to Commerce is Paris Junior College. If you take the exam at a junior college, you are required to take the exam on the same day the midterm is given in Corsicana AND you must send me the name, email address, and phone number of the director of the testing center you wish to have your test sent to at least one week in advance. Failure to meet this deadline will require that you come to Corsicana to take the exam.

Final Exam:

On July 8th, you will take the final exam from 12:00 pm— 2:00 pm. The exam will be on the Corsicana campus of TAMU-Commerce. The room will be announced at a later date.

Your only other option is to pay to take the exam at a local junior college testing center. The exam will not be given in Commerce and Commerce does not have a testing center for you to use. The closest testing center to Commerce is Paris Junior College. 
