Course Description

This course is an overview of the nature and scope of the administrative issues in the sport industry and recreational agencies and will expand the students' understanding of management theories and their application to sport and recreation administration.

- Be able to define organizations and management in sport and recreation environments.
- Have a basic understanding of strategic management planning, decision-making processes, continuous improvement theory, performance motivation, human resource management, and managing change in sport and recreation organizations.

The sections will include the following:

<u>Quizzes</u>: You will take several multiple choice and true/false questions to test your understanding of the required readings (will be scored out of 25pts).

<u>Written assignments</u>: You will be asked to write short papers on a variety of issues/topics. These assignments will have instruction sheets for them and will be graded out of 100pts.

Each written assignment will have two due dates:

- 1) The first due date will consist of your submission of the first half of the paper failure to turn this in on time will result in a 10pt deduction from your overall grade on the final submission of the assignment
- The second due date will consist of your submission of the finalized paper – failure to turn this in on time will result in a zero grade given for the assignment

TECHNOLOGY REQUIREMENTS
