COURSE INFORMATION

Course Description

A survey of the fields of theatre activity designed to provide introductory knowledge of all phases of drama, literature, performance, theatre plants and equipment, and production procedures.

This course has been selected as a Global Course – tied to the QEP. The QEP seeks to prepare students for an interconnected world. In relation to the QEP, students completing this course will be able to (LO1) demonstrate knowledge of the interconnectedness of global dynamics (issues, trends, processes, and systems), (LO2) apply knowledge of the interconnectedness of global dynamics, and (LO3) view themselves as engaged citizens within an interconnected and diverse world. This course will provide activities, experiences, and opportunities to reach all of the QEP learning outcomes. The posttest in this course will assess the OEP student learning outcomes.

Course Competencies

- 1. Students will demonstrate knowledge of the foundational characteristics of theatre.
- 2. Students will exhibit understanding of the historical underpinnings of Western theatre and express contextualized and tolerant interpretations of different types of dramatic literature.
- 3. Students will display knowledge of major artistic positions in the theatrical discipline.
- 4. Students will evaluate creative works of the human imagination, applying appropriate disciplinary standards of judgment and vocabulary.
- 5. Students will illustrate comprehension of theatre as a collaborative art form and develop creative capacities.

Pretest and Posttest

The Pretest and Posttest for this Theatre course assess your knowledge of all phases of drama, literature, performance, theatre plants and equipment, and production procedures.

The Posttest is an assessment of your knowledge of the material required for the competency. A score of 80 points or higher is required to demonstrate competency. If you score less than 80 points on any competency you will have an opportunity to review the material and re-take the competency Posttest. You may take the Posttest assessment up to three times. If you have not passed the competency in three attempts, you will work

with an Academic Coach to determine another method of fulfilling the program requirements in this subject. In order to demonstrate competency, a score of 80 points or higher is required.

Students who are unable to successfully complete all competencies mapped to a course, upon approval of their instructor have the option to receive a mark of "X" (incomplete) in the course in which they are maintaining satisfactory progress toward competency completion. You must re-register for the course again in the subsequent term. You understand that the grade of X will remain on your transcript indefinitely. However, failure to re-register for the course during the next term will result in a grade of F being posted for your incomplete competency course.

TECHNOLOGY REQUIREMENTS

This is an online course and the following technological resources are required:

- Speakers so you can hear audio enhanced assignments throughout the semester
