Required Textbook:

Musical Theater: An Appreciation by Alyson McLamore, Pearson Prentice Hall, 2004.

Catalog Course Description:

This course will concern the questions and problems raised by the fusion of words and music in musical theatre. Classical and popular repertory from many different nations and cultures are examined.

Course Introduction:

This course will provide a thorough grounding in the history of Western musical theatre, and introduce a number of non-Western forms. Students will become familiar with major movements and practitioners, as well as acquiring an appreciation of musical elements.

Student Learning Outcomes: By the end of this semester, the student will be able to:

1. Identify and discuss the major practitioners, shows, and movements of Western musical theatre.
2. Analyze the musical elements in any piece from musical theatre.
3. Identify and discuss the non-Western forms presented during the course.
4. Analyze and contextualize any piece of Western musical theatre.
5. Create and deliver a powerful presentation using multimedia software.
6. View, analyze and perform pieces from the shows discussed.

Instructional / Methods / Activities Assessments:

You are expected to do the reading in advance, and come to class prepared to participate in discussion.

Assignments:

1. Quizzes. Quizzes will test your understanding of the glossary terms in the material covered (the terms are in bold in the textbook). The quizzes will be administered in class. See the course schedule for dates.
2. Chapter presentations. Students will team up in groups of two at the beginning of the semester. Teams will present chapters from the textbook, using multimedia software (No Powerpoints.) Teams will not be responsible for playing and analyzing the musical examples at the end of the text – the instructor will do this. Additional instructions will be distributed. These are due by email before noon on the day your present.
3. Show selection Presentation-each student will research a musical that could possible fit into an upcoming season. Parameters and expectations will be administered at a later date.
4. Research papers. You will research and write a 3-4 page research paper on an element of Lyric Theatre we have studied. Topics can include composers, cast members, the journey the show took from an idea to the Broadway stage, any revivals that have made it back to Broadway, adaptations to and from screen, historical significance of the show, technical advances, etc.
5. Musical Film Viewing Presentations. Each class member will choose a film from the time period we are currently studying and create a presentation to inform the class. Assignment sheets for the Viewing Presentations will be handed out specifying format and content.
6. Midterm exam. This will test the student's understanding of the material through the midterm.
7. Final exam. A comprehensive exam covering the material for the entire semester.

All assignments must be neatly typed (no larger than 12-point font), double spaced, with margins no larger than 1.25 inches. Pages must be stapled together in the upper left hand corner. (No paper clips, torn corners or folder covers please.) Assignments that are not stapled will not be accepted. Buy a stapler today! Assignment may not be longer or shorter than indicated. Additional instructions will be issued for the formatting of your research paper.

COURSE AND UNIVERSITY PROCEDURES/POLICIES

Course Specific Policies and Procedures:

ATTENDANCE: This course follows the attendance policy found in the general catalog. After your third unexcused absence, there will be a 5% grading penalty per absence. A sixth unexcused absence may lead to administrative withdrawal. In order for an absence to be excused, you must contact the instructor in advance and/or provide documentation. If your partner is absent on the day of the presentation, it is your responsibility to proceed with the presentation. If you are absent on the day of your presentation, and have not made arrangements with your partner or notified the instructor, your presentation grade will be penalized.

LATE ARRIVALS: I take role at the beginning of every class period. If you arrive after I have taken role, then you are late. It is your responsibility to make sure that you find me after class and document your late attendance for the day—otherwise, your initial marked absence documented during roll will remain. Also, you are expected to stay until you are dismissed from class. Two late arrivals or early departures (or any combination of the two) will be counted as one absence in the class.

ELECTRONIC DEVICE POLICY:

Cell phones, text message, social media, etc.-Use of cell phones, messaging devices, and other electronic devices (for example, recording devices, music players, PDAs, computers) is prohibited in class unless specifically permitted by the instructor, or if the device is being used as a component of class learning activities. Failure to abide by this electronic device policy may result in corrective action by the faculty instructor. This may include being marked absent on the day of the infraction. Computer use during class time is limited to course-relevant activity. Web-surfing, video watching, etc. are not allowed.

Class recording/image capture-The use of personal recording devices (tape, digital, video, web camera, etc.) requires instructor approval.

Student should request permission to record class activity in writing.

LATE WORK: Written assignments are due at the beginning of the class period – otherwise they will be counted late. Late written work/projects will be deducted a full letter grade each class session after the Assigned due date. This means that if you have to be absent for some reason on the day a written assignment is due, you must give your assignment to one of your classmates to hand in for you, or you will receive a grading deduction. No assignments will be accepted more than one class period late. Work will not be accepted by e-mail unless specified.

EXTRA CREDIT: As a general rule, there is no extra credit offered in this class– please, do not even ask. In the rare instance that an extra credit opportunity arises, that opportunity will be announced and equally available to all members of the class.
