Course Description

An advanced and comprehensive introduction course on the fundamentals financial planning. A review of the financial planning process and regulatory practices in the field of financial planning will be completed. Advanced techniques of personal sector cash flow, asset and liability management, life cycle financial planning, investment management, tax planning, and retirement and estate planning. Client communication strategies will also be examined.

Student Learning Outcomes

Upon completion of this course students should be able to do the following:

- 1. Understand the importance of financial planning.
- 2. Have a solid understanding of the multiple areas of financial planning including: cash management, taxation, insurance, retirement, investments, and estate planning.
- 3. Demonstrate the ability to review different types of client data and help set financial goals.
- 4. Understand the consumer financial laws and how they help future clients.

COURSE REQUIREMENTS

Instructional / Design of Course

The class will be conducted in a lecture/discussion format. There will be a combination of recorded and live classes using Class Live Pro. Be prepared to discuss and ask questions about the material assigned for each class period. **This class is broken up into 8 modules and moves VERY quickly.** The instructor will communicate with students through the entirety of the semester. Students should look in eCollege and their university e-mail for course updates.

Students are expected to be read the book prior to attending/watching the online lectures. All live lectures will be recorded and attendance is not required, but encouraged. Students should also work the practice problems after each chapter in order to master the material

Student Responsibilities

Students are expected to be engaged in the class by watching the lectures and asking questions on the discussion board. It is up to the student to increase his/her knowledge in finance; specifically risk management and insurance.

GRADING

Exams

There will be three exams including the final. You will be responsible for information from class discussion, required readings, and any guest speakers. <u>All exams are timed and must be taken within a 24 hour window.</u> Please adjust your schedule to allow time for the exams. <u>The final exam score can replace ONE of your lower exam scores from your previous two exams.</u>

Quizzes

You will receive quizzes during the semester; these should introduce you to the types of questions you will experience on your exams and will count towards your grade. These quizzes will include text questions and/or supplemental activities. Your lowest quiz grade will be dropped at the end of the semester. <u>All quizzes are due by at 11:59 pm as specified on the</u> <u>course outline. There will be NO quizzes on days where an exam is</u> <u>due.</u>

Cases

There will be 1 group case this semester where students help a client reach their financial goals by implementing a financial plan focusing on cash management, debt reduction, and savings goals. Graduate students will have a substantially different case then undergraduates. This course will be cross listed with undergraduate and graduates. Graduate students will be graded at a higher level. Final grades in this course will be based on the following scale:

TECHNOLOGY REQUIREMENTS

- To fully participate in online courses you will need to use a current Flash enabled browser. For PC users, the suggested browser is Google Chrome or Mozilla Firefox. For Mac users, the most current update of Firefox is suggested.
- You will need regular access to a computer with a broadband Internet connection. The minimum computer requirements are:
