Reading Assignments:

The reading assignments and class sessions are listed for each week. I expect you to complete the readings prior to class and be **PREPARED** to discuss and address specific issues raised in the readings. Written assignments will be submitted to the instructor at the beginning of the class period. The material covered in the assigned readings can be on the exam even if the information not covered in class. READ the assigned readings.

Critical Analysis

Each student is required to complete a 1 (One) critical analysis of the weeks reading. There are 5 (Five) weeks during the summer session you are required to submit 5 (Five) Critical Analysis. The focus of the analysis will be focused on the articles presented and your analysis is encouraged. Each analysis should be 2-3 (Two - Three) typed pages with 1" margins, 12pt Times New Roman font. Your critical analysis will be due Monday of each week.

Attendance and Participation

Any absence requires proper documentation. Family emergencies, illnesses, births, deaths, incarcerations or other events and calamities are NOT excused absences. Participation *points are earned through your contribution to class discussion* that reflects informed and on-topic participation. Participation means that you read the required chapter material in preparation for class. If you are not in class, then you cannot earn participation credit. If you miss three classes, the instructor reserves the right to drop any student from the course. Attendance and Participation consists of 20 % of your final grade.
