Welcome to ACCT 562, Forensic and Investigative Accounting, where we will study how to use accounting information and methods to: (1) describe types of financial fraud schemes and risks; (2) identify the rules of evidence and civil procedure as they relate to successful forensic and expert testimony; and, (3) determine amounts of commercial or economic damages.

Prerequisites for our class are ACCT 321 and ACCT 322, ACCT 502, or equivalent classes.

Our textbook is Forensic and Investigative Accounting, 7<sup>th</sup> edition, by Crumbley, Heitger, and Smith, published by Commerce Clearing House, ISBN: 978-0-8080-6. Other useful materials are posted in our eCollege page.

We will meet online, in eCollege, from June 6 until August 11. On Mondays, we will meet in eCollege "Class Live" at 9 pm, beginning on Monday, June 6. You are not required to attend classes, which are recorded.

Your final grade will be determined by four tests and six homework assignments. Tests determine eighty percent of your grade and homework twenty percent. 90% of possible points are required for a final grade of "A"; 80% for a "B"; 70% for a "C", and 60% to avoid an "F".
