### ***Course Description***

Catalog Description: A survey of children's literature. The course includes various authors and illustrators in such genres as the oral tradition, fantasy, realistic and historical fiction, poetry, and the picture book. Prerequisite Eng 1302

## ***Assignments and Assessments***

I cannot tell you at this time exactly how many points will be available for the course, for quizzes will have different point values and have not yet been determined. Additionally, I might need to make different assignments depending on the needs of the students. This is what I plan for the course, though.

**Quizzes:** 10-40 pts each

**Discussion Boards,** 10-40 pts. each

**Possible minor assignments** depending on needs of class (but I'm not anticipating anything)

**Final Project, 100 pts.:** Identify a particular time (WWII, WWI, Revolutionary War, Civil War, etc.) or group of people/event (eugenics programs as depicted in children's literature (see for instance *Hidden Roots*), immigration experiences, etc), and do what I've done for this course. This isn't for children; assume it's for a **200-level college children's literature course**. Create a required selection of 5 books with a rationale for those books, individually and overall, an introduction to the course (something like I wrote but it can also be very different), and 2 scholarly articles or book chapters that students would need to read (with a rationale). More details to follow.
