# **Course Objectives/Learning Outcomes**

- To increase your understanding of how participation in sport, exercise, and physical education influences the psychological makeup of the individuals involved
- To help you acquire skills and knowledge about sport and exercise psychology that you can apply as a coach, teacher, athletic trainer, or exercise leader
- Describe the field and history of sport psychology
- Discuss the theoretical foundations of the psychological processes that operate in a variety of sport settings.
- Recognize the processes of learning, anxiety, and performance enhancement.
- Discover how participation in sport influences the psychological makeup of the individual involved.
- Apply motivational principles to "real world" settings.
- Identify the psychological processes for both individual and group processes.

# **Course Policies**

### TECHNOLOGY REQUIREMENTS

- To fully participate in online courses you will need to use a current Flash enabled browser. For PC users, the suggested browser is Google Chrome or Mozilla Firefox. For Mac users, the most current update of Firefox is suggested.

JavaScript is enabled.

### Collusion is defined as:

APA Citation Format Policy

It is very important that you learn how to cite properly. In some ways, citations are more important than the actual text of your paper/assignment. Therefore, you should take this task



seriously and devote some time to understanding how to cite properly. If you take the time to understand this process up front, it will save you a significant amount of time in the long run (not to mention significant deductions in points).

In the social and behavioral sciences, we use APA (American Psychological Association) format. As a rule of thumb, one cites whenever they are paraphrasing other people's words or when they quote other's words directly. You may learn to cite from a variety of different sources including the APA Tutorial and the sources listed below and in the Getting Started section of your course. www.apastyle.org
