## **Course Description**

This course will explore various curriculum models and underlying theories utilized in designing early childhood curriculum. Additionally, participants will examine factors that have influenced

curriculum development in Early Childhood Education. Moreover, participants will determine how certain factors have influenced the development of a variety of curriculum models that have shaped present curriculum in early childhood education.

#### **Course Goal:**

To help students recognize appropriate ECE environments that promote active handson learning, respect children as individuals, and allow for the development of the whole child.

As a result of participating in this class, students will:

- 1. Identify significant factors that have influenced curriculum development in early childhood education.
- 2. Analyze curriculum models that have been used in a variety of early childhood programs.
- 3. Critique early childhood curriculum framework that reflects best practices to promote the growth and development of all children.
- 4. Generate an early childhood curriculum framework that reflects best practices to promote the growth and development of all children.
- 5. Describe distinguishing features of major early childhood curricula models and programs.
- 6. Classify different early childhood curriculum models in relation to the philosophical/theoretical/historical base of the curriculum model.
- 7. Demonstrate leadership ability as a professional educator for analyzing curriculum materials and models with particular attention to assessment, content, connections and alignment to state and national standards.
- 8. Synthesize knowledge of evaluation research involving the comparisons of curriculum models.
- 9. Examine the relationship among theory, research, and practice regarding major curriculum models.
- 10. Continue the development of a personal philosophy and knowledge base necessary to provide leadership in curriculum development and implementation in the field of early childhood education.
  - The learner will be an active and engaged participant in discussion forums by analyzing, constructing/creating, and evaluating information presented within the textbook, external readings/resources, student research, and class activities.
  - The learner will demonstrate an understanding of the methods used in education by creating a DAP Book, highlighting the technology employed, and the appropriateness and effectiveness in the study of early childhood education.
  - The learner will also demonstrate understanding of the course materials through objective examinations.

# **Withdrawal Policy**

#### TEXAS SENATE BILL

Texas Senate Bill - 11 (Government Code 411.2031, et al.) authorizes the carrying of a concealed handgun in Texas A&M University-Commerce buildings only by persons who have been issued and are in possession of a Texas License to Carry a Handgun.
