Student Learning Outcomes/Objectives

The main purpose of this course is to examine Social Inequality from a Sociological Perspective and provide an overview of the field of Social Stratification. Social Inequality, or Social Stratification, is a major feature of our daily experience. This course studies the distribution of three primary resources: class, status and power. Special attention is given to examine the ascribed statuses such as age, sex and race interacting with achieved statues such as class, status and power stratification systems. Also the course will inspect the popular and scientific explanations of inequality, especially with respect to the high and low ends of the distribution of income and wealth.

- To examine the basic sociological concepts and perspectives on social inequality and stratification:
- To understand the major sociological explanations for social inequality both within the United States as well as the global;
- To recognize what practices and institutions shape these diverse social groupings;
- To enable you applying the course material to your real-life experiences;
- To compare and contrast the popular/public perception of inequality with an academic/intellectual analysis of inequality.

As per the university rule, students taking one course with three credit-hours are expected to spend six hours weekly on studying lecture online, watching videos clips, reading chapters, doing assignments, and preparing quizzes and exams.
