## **Course Description**

This course is designed to practice conducting case studies and scientific research on latest trends in technology management. It will focus on four key components of project management; (1) measuring project performance, (2) risk management, (3) cost analysis, and (4) quality management. (Note: This course is 100% online).

1. Conduct scientific research.
2. Evaluate and recommend features of measuring project performance.

4. Utilize quality management tools effectively and efficiently.
5. Design optimum methodologies for cost analysis.

## **COURSE REQUIREMENTS**

This course consists of a series of:

- Assignments (short questions, essay questions, discussion posts, and case studies),
- a final exam, and
- a final team project.

Each week you will work on various combinations of these. The format requirements for each assignment will be provided on eCollege course page.

Since this is an online course, all course work will be posted on the eCollege course page. All your work must be submitted online to the designated dropbox.

## TECHNOLOGY REQUIREMENTS

## LearningStudio Notifications

Students can be alerted to course activities via text on their mobile phones or up to two email addresses.

Based on their preferences, students can automatically receive a push notification with every new: course announcement, threaded discussion post, grade, and/or assignment without having to login to the course. Enrolled students will automatically receive email notifications for announcements and can opt out of this feature. To receive text notifications, students must opt in.

To begin setting up notifications, go into your course in LearningStudio and click on the bell-shaped Notifications icon on the main menu ribbon.

By default the student's university email address will appear. This cannot be changed in LearningStudio. Additional email addresses may be added by clicking the Add button. After all of the other selections are completed be sure to click the Save and Finish button.
