Course Description

A study of common infectious and non-infectious microorganisms and parasites that cause disease and the methods to control and prevent them in livestock.

Student Learning Outcomes

- 1. The student will able to describe selected major livestock diseases/parasites with understanding of each in the following categories
 - a. History/Prevalance
 - b. Etiology
 - c. Diagnosis and Signs
 - d. Treatment
 - e. Prevention
- 2. Design and implement power point lectures that could be used in teaching situation.

Course Specific Procedures/Policies

Materials

Required text: None. All resources will be provided by the instructor.

Overview

Under the direction and approval of the instructor, 8 topics will be chosen for the student to research and study. The student will present what they have learned for each topic in a PowerPoint presentation that would be suitable for a lecture or presentation. The format, expectation, and grading criteria of the PowerPoint presentations will be provided at the time of topic approval. Each assignment will be reviewed by the instructor and feedback given to make corrections or suggestions to improve the presentation for each assignment.

Presentation Guidelines

Use the following guidelines for each presentation.

- 1. The minimum # of slides is 18 with the following criteria:
 - First slide is Title Page slide with your name and title
 - Slide #2 is a list of 3 or more lecture learning outcomes or objectives. What do you expect a student to be able to do at the end of the lecture?

For Example:

"After completion of this unit the student should be able to _____"

- i. Describe
- ii. Explain the following
- iii. Define the following terms
- iv. Identify
- v. Name
- The remaining 12 slides
 - i. For each slide that is only a figure, table, or graph or pictures (slides with not text) then there MUST BE a slide to introduce or immediately following to summarize.
 - ii. A maximum of 6 slides that are text only that is not associated with any figure or text.
 - iii. Slides should be concise, direct, and readable (Minimum font = 28). Use bullets to emphasize points. Do not use paragraphs.
 - iv. When addressing a specific disease address the following in the presentation
 - 1. History/Prevalance
 - 2. Etiology
 - 3. Diagnosis and Signs
 - 4. Treatment
 - 5. Prevention
- 2. Place completed power point in the Ecollege dropbox by the due date!

TECHNOLOGY REQUIREMENTS

LearningStudio Notifications

Students can be alerted to course activities via text on their mobile phones or up to two email addresses.

Based on their preferences, students can automatically receive a push notification with every new: course announcement, threaded discussion post, grade, and/or assignment without having to login to the course. Enrolled students will automatically receive email notifications for announcements and can opt out of this feature. To receive text notifications, students must opt in.

To begin setting up notifications, go into your course in LearningStudio and click on the bellshaped Notifications icon on the main menu ribbon. By default the student's university email address will appear. This cannot be changed in LearningStudio. Additional email addresses may be added by clicking the Add button. After all of the other selections are completed be sure to click the Save and Finish button.
