COURSE INFORMATION

Textbook(s) Required: Corrections: The Essentials (13th Edition, 2012). ISBN-978-1-4833-7224-2, Sage Publications

Course Description: A theoretical, historical, and pragmatic overview of institutional corrections, including the administration, design, and organization of adult prisons and jails and juvenile detention facilities and reformatories. An examination of punishment and treatment philosophies and objectives.

Student Learning Outcomes:

- 1. Students will be able to explain the relationship between society and offender.
- 2. Students will be able to demonstrate an understanding of the philosophical bases by which offenders are treated.
- 3. Students will be able to describe the broader forces at work in institutional and community corrections.
- 4. Students will be able to differentiate between corrections of misdemeanants and felons.
- 5. Students will be able to describe the correctional systems in different countries.
- 6. Students will be able to analyze the historical development of the correctional system in America.

COURSE REQUIREMENTS

Instructor's Expectations of Student

- 1. Attend class regularly
- 2. Read material before class
- 3. Active participation in discussions (not just "I agree/disagree")

Instructional Methods

The method of instruction for this course will be a combination of lectures, discussions, and group activities. The specific activities used to engage students in mastering chapter material will be classroom participation, online discussion boards, three unit exams, and a research paper which will also count as your final exam. Because our class time is limited, it is extremely important for you all to participate in the online portion of the class to maximize your learning experience in this course.

There will be three exams throughout the course which will be taken online via college. Each exam will contain multiple-choice, matching, essay and true-false questions. Each examination will be weighted equally.

You will also submit at least a ten page paper at the end of the semester. It is not to be an argumentative or opinion paper, but a research paper. This paper must be written based on a discussion and analysis of a course related issue. Please, use APA format writing style for this paper. The paper will be graded on content as well as exposition. There will be a 20 point penalty for late submission.
