Course Description

This course will provide a survey of metabolic processes in domestic farm animals as it relates to digestion, absorption, and cellular metabolism of macronutrients including carbohydrates, fats, and proteins. Integration of metabolic pathways for nutrient utilization by various body tissues will be discussed.

Student Learning Outcomes (Should be measurable; observable)

Upon successful completion of this course, students will be able to:

1. identify key steps in the digestion and absorption of carbohydrates as well as their metabolism at the cellular level.
2. identify the key steps in the digestion and absorption of fat as well as the metabolism of fatty acids at the cellular level.
3. identify key steps in the digestion and absorption of protein as well as the fate of key amino acids in metabolic pathways at the cellular and interorgan level.
4. discuss and/or diagram how the above macronutrients are metabolized differently depending on the nutritional state of the animal (energy abundance or energy deficiency).

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students should be able to use the Microsoft Office 365 software package, browse the internet, and use email to complete this course successfully.

Instructional Methods

This course will primarily use asynchronous delivery of course content and reading assignments from the required text for the students. During the 1st week of class, the students will select a one hour time slot for a weekly synchronous online discussion session to ask questions, give routine homework assignments, and clarify content in the course. The instructor will also provide routine announcements/emails concerning deadlines for assignments and adjustments to the course schedule.

Student Responsibilities or Tips for Success in the Course

Communication is the key to success in any interpersonal activity, and online courses are no exception. Please do not hesitate to contact the instructor with any questions that you may have. I look forward to your questions as part of the learning process. Students will need to be diligent with their time management in the online course to make sure that they stay up on the reading assignments and discussion times. Although the course is online, you should plan to devote the normal time allotted for a 3-credit course of similar complexity in order to be successful.

Discussion participation, routine homework, and exams will be graded within a week of submission. The metabolism poster and PowerPoint Presentation projects will be discussed in greater detail during class, but these two projects will be due in final form the week following the Thanksgiving holiday. These two assignments will be graded by final exam week.

TECHNOLOGY REQUIREMENTS

LearningStudio Notifications
