Study of construction operations projects management and project planning. Includes scheduling, rough diagram preparation, calculating costs, presentations, and controlling. Prerequisites: TMGT 336

- 7. Differentiate the process of building a project estimation at different levels of details
- 8. Develop a simple construction schedule using the critical path method
- 9. Explain the basics of project monitoring, controls, and safety requirements

## **TECHNOLOGY REQUIREMENTS**

#### LEARNINGSTUDIO NOTIFICATIONS
