Course Content:

This course will include content and pedagogy for teaching sets, functions, numeration systems, number theory, and the properties of the natural numbers, integers, rational, and real number systems with an emphasis on problem solving and critical thinking. Prerequisites: "C" or better in MATH 1314.

Student Learning Outcomes: Students will be able to:

1. understand numbers, ways of representing numbers, relationships among numbers and number systems,
2. understand meanings of operations and how they relate to one another,
3. compute fluently and reasonable estimates
4. understand patterns, relations and functions
5. represent and analyze mathematical situations and structures using algebraic symbols

6. use mathematical models to represent and understand quantitative relationships
7. analyze change in various contexts analyze

The goal of this course is to develop *understanding* of the mathematics. We are constantly going to be dealing with *WHY* more than *HOW*. We will focus on underlying structures and development of ideas. In addition, problem solving is a major component of this course. As professionals, you need to become familiar with and skilled in various types of problem solving techniques that are commonly used in mathematical thinking.

Make-ups: If for some reason you have to miss the midterm, then the final will count 60% of your grade.

Course Grading: Will be based on Research Projects, a Midterm Exam, Homework, Discussion Boards and a Final Exam.

TECHNOLOGY REQUIREMENTS

LearningStudio Notifications

Students can be alerted to course activities via text on their mobile phones or up to two email addresses.

Based on their preferences, students can automatically receive a push notification with every new: course announcement, threaded discussion post, grade, and/or assignment without having to login to the course. Enrolled students will automatically receive email notifications for announcements and can opt out of this feature. To receive text notifications, students must opt in.

To begin setting up notifications, go into your course in LearningStudio and click on the bell-shaped Notifications icon on the main menu ribbon.

By default the student's university email address will appear. This cannot be changed in LearningStudio. Additional email addresses may be added by clicking the Add button. After all of the other selections are completed be sure to click the Save and Finish button.
