Course Description: This course is designed to examine the physiological and sociological effects of drugs and other harmful substances. Legal and ethical implications will also be considered.

- 4. Survey the historical influence on the drug-oriented society and its bearing on personal drug behavior to include laws that arise related to substance use, misuse, and abuse.
- 5. Identify alternative highs to drug use highs and how they relate to healthy attitudes and behaviors.
- 6. Identify factors and examine issues in making responsible choices about drugs (e.g. decision-making, refusal skills).
- 7. Make a distinction between over-the-counter (OTC) medications, prescription medications, alcohol, tobacco, and a number of illegal drugs.

COURSE REQUIREMENTS

Instructional / Methods / Activities Assessments

We will review many legal and illegal substances commonly used and abused. Activities include discussions of timely topics, application of knowledge through quizzes and exams, and a review of the literature on a substance use and abuse topic.

<u>Assignment 1: E-college Quizzes</u> (8 quizzes at 50 points each = 400 points)

- 6. Identify factors and examine issues in making responsible choices about drugs (e.g. decision-making, refusal skills).
- 7. Make a distinction between over-the-counter (OTC) medications, prescription medications, alcohol, tobacco, and a number of illegal drugs.

You will take 8 quizzes over material presented in assigned readings (i.e. websites and articles); the chapters of the book; and lectures. Each quiz will be timed and must be completed within the assigned time frame (Check your course calendar for due dates). The purpose of the quizzes is to ensure that you have the basic knowledge to perform other activities in class such as discussing, researching, and writing about a variety of substances and issues related to them.

Assignment 2: Discussions (7 discussions at 40 points = 280 points)

- 7. Make a distinction between over-the-counter (OTC) medications, prescription medications, alcohol, tobacco, and a number of illegal drugs.

Seven discussions will be available during the term. You are required to participate in all seven discussion boards. You should also post a minimum of 2 posts per discussion thread: one initial post answering the question and one response post to your fellow classmates that further the discussion. Initial post should be a minimum of 75 words. Responses should go beyond 'I agree" or "I disagree". Please be thorough and engage in the conversation.

LearningStudio Notifications

Students can be alerted to course activities via text on their mobile phones or up to two email addresses.

Based on their preferences, students can automatically receive a push notification with every new: course announcement, threaded discussion post, grade, and/or assignment without having to login to the course. Enrolled students will automatically receive email notifications for announcements and can <u>opt out</u> of this feature. To receive text notifications, students must opt in.

To begin setting up notifications, go into your course in LearningStudio and click on the bell-shaped Notifications icon on the main menu ribbon.

By default the student's university email address will appear. This cannot be changed in LearningStudio. Additional email addresses may be added by clicking the Add button. After all of the other selections are completed be sure to click the Save and Finish button.
