##### ***Course Description***

Computer programming for business applications; emphasis on design, development, testing, implementation, and documentation of software.

Prerequisites: CSCI 151 or equivalent.

Note: we are currently in the process of updating the above course description. The following is the updated version of CSCI 233 course description.

This course is for anyone who wants to learn how to build and maintain websites that use PHP and MySQL. In particular, this course will expand basic MySQL and PHP skills to include the skills you need for building full-fledged database-driven web applications. For this course you should have a basic HTML and CSS skills.

Prerequisite: CSCI 151 or equivalent.

##### ***Student Learning Outcomes***

Design and develop a basic report program.  
Enhance a basic report program to process grouped data and summarize results.  
Learn the programming constructs and develop programs to create and process arrays.  
Develop a program to capture, process and store object data (class instance) into a file.  
Design and develop a program to process a sequentially-organized file.  
Develop a program to access data from a database.  
Design and develop a basic input form to capture data for an application.  
Design and develop pages for a basic online application (team project).

## **COURSE REQUIREMENTS**

### ***Minimal Technical Skills Needed***

Students planning to enroll for this course should have mastered the objectives set for an introductory course in computing including the fundamentals of programming (e.g. CSCI 151).

### ***Instructional Methods***

If this course is Face to Face (Lecture), then factual material is presented in a direct, logical manner to motivate the student.

### ***Late Policy***

The deadline for any assignment can be extended with a 15% penalty per day. No deadline can be extended by more than two days. Assignments will NOT be accepted 48 hours after the due date. No technical excuse (e.g., eCollege technical problem).

### ***Makeup Policy***

There will be no makeup exams in general. Makeup exams may be given to students under extreme circumstances, such as hospitalization, serious injury, death in the family etc., with prior notification and official documents. Students are expected to do the readings, attend class, and participate in class discussions.

If this course is Face to Face (Lecture), then I **Do Not share my PowerPoint slides and class notes**, except under extenuating circumstances. You are responsible for the content of all classes, including issues raised in the spontaneous class discussions. If you must miss a class, please request notes from your classmates prior to contacting me. Attendance may be checked at random throughout the semester.

Any assistance, though, must be limited to discussion of the problem and sketching general approaches to a solution. Each student must write out his or her own solutions to the homework. These and any other form of collaboration on assignments constitute cheating. If you have any question about whether some activity would constitute cheating, please feel free to ask.

### **LearningStudio Notifications**

Students can be alerted to course activities via text on their mobile phones or up to two email addresses.
