Course Description: Advanced Auditing course is an intensive study of professional conduct, auditing standards, auditor's liability, reports, and internal auditing. This course focuses on advanced auditing principles as related to publicly traded organizations, the general public, and the audit firm in general. For each class, the presentation and class discussion will incorporate the related accounting principle, the appropriate auditing standards and applicable professional standards. The importance of ethical accounting practices will be emphasized throughout the course.

- 1. Demonstrate an understanding of planning and conducting an engagement including making assessments of audit risk, fraud, materiality, and deciding the nature, timing and extent of tests.
- 2. Identify objectives for particular audits, select and apply tests of control and substantive procedures to obtain appropriate audit evidence, evaluate the evidence, and draw reasonable conclusions.
- 3. Apply relevant account and reporting standards to evaluate and form opinions and financial statements.

#### **COURSE POLICIES**

CASE PRESENTATION: You are able to achieve a total of 300 presentation points for the semester. You will NOT be able to make up any missed presentations. You will make 3 group presentations this semester and each group will be formed at the beginning of this semester. For the presentation, you need to summarize the case and addressing the case questions. The final presentation file must be attached in myLeo Online before midnight the day before the group will make the presentation. Each student is required to upload the final presentation file by 11:55pm the night prior to the presentation. If you do not upload the final presentation file you will lose one-half of your presentation points for that assignment. If you are NOT present for the presentation, you will lose all of your presentation points since it will be counted as a missed assignment.

Each presentation is worth 100 points and your colleagues' assessment of your presentation will consist of 50% (50 points) of your grade. I will use the same rubric as your colleagues and provide up to 50% (50 points) of your presentation grade.

**PARTICIPATION:** You are able to achieve a total of 100 participant points for this semester. Beginning on the fifth week of class, each student will have 11 opportunities for class participation. Therefore, each student can earn up to 10 points per day for class participation.

In order to receive 10 points, you must provide critical, challenging and interesting ideas to the class discussion, active participation to the class discussion will earn you 5 points, and attendance alone will earn you only 5 points.

You need to prepare well before you come to every class. The discussion topics include but not limit to the questions from each case study.

**EXTRA CREDIT:** You have an opportunity to obtain 10 extra credit points from your class participation.

Late work – Due dates are posted on the syllabus and in our myLeo Online course. Assignments, exams, quizzes, etc. must be submitted no later than the date outlined in our course. Absent extenuating circumstances, late work is not accepted. Extenuating circumstances do NOT include forgetting, technical difficulties or running out of time. The evaluation of an extenuating circumstance is judged on a case-by-case basis. Documentation MUST be provided in a timely manner. A 30% late penalty may apply even if an extenuating circumstance exists.

**Exam** – The final exam is given in class. It draws questions we discussed throughout the course. The content of the final exam with include a mixture of fact-based questions, and essay questions that will require analysis and comprehension, not mere memorization. The exam will be administered on the date outlined in our course. Make-up exam is given **ONLY** under extenuating conditions. The following are considered extenuating conditions: hospitalization, medical emergency, physical injury, or death of an immediate family member. You **MUST** bring proof of the extenuating circumstance in order to facilitate an exam make-up. Proof of the extenuating circumstance must be received in a timely manner. For extenuating conditions make-up exams/quizzes must be taken within three days of release or recovery. A 30% late penalty

may apply even if an extenuating circumstance exists. Students attending university sponsored events must provide necessary documentation in order to accommodate any make-up exam/quiz.
