## **Course Description:**

A survey of the underlying ideas, principles, and participatory practices of constitutional government in the United States and Texas. Topics considered include civil liberties and civil rights, constitutionalism, federalism, ideology, pluralism, political culture and socialization, political parties and interest groups, public opinion, republicanism, and voting and electoral politics.

#### **Format:**

Each class session will involve lectures and discussions about the assigned readings. You will regularly be asked to contribute your opinions and answer questions about the readings. In addition to the assigned readings listed in the syllabus, we will regularly discuss current political events, since developments in American politics occur on a daily basis.

This syllabus is subject to change at any time at the professor's discretion.

## **Requirements/Assignments**

**Examinations:** In this course, **all students are required to take <u>three</u> exams,** each of which will consist of 50 questions in a multiple choice format. Together, these exams will comprise **90%** of your grade (each exam is worth 30%). The exams are NOT comprehensive. **There is NOT a final exam in this course.** 

If you miss an exam, you will receive 0% for that exam.

If you have a **legitimate reason** for missing an exam (e.g. severe illness or injury *requiring professional medical care*, emergencies in your *immediate* family, participation in *official* university activities, legal *obligations*) **AND** you have **supporting documentation** for your absence, then you may **request** taking the **MAKE-UP EXAM**, which will **BE GIVEN AT 4:45pm on Wednesday**, **October 3 (Exam 1)**; **4:45pm on Wednesday**, **November 14 (Exam 2)**; **Exam 3 will be given during FINALS WEEK and CANNOT BE MADE UP.** 

Requests for taking the make-up exam must be **submitted in writing and include documentation** explaining and substantiating why the absence was legitimate. An approval to take the make-up exam will be based solely upon the professor's evaluation of your request and any supporting documentation.

Attendance: Attendance is critical, discussions are irreplaceable, and course sessions cannot be "made up." It will be extremely difficult, if not impossible, for you to succeed in this course if you do not attend all –or nearly all- class sessions. Attendance will be taken during each class session using a sign-in sheet for financial aid and other documentation purposes, however it will not directly affect your grade. Signing in a student who is not present or a asking a student to sign you in when you are absent constitutes academic dishonesty (see p.3). Since your attendance will not be used to calculate your grade, it is <u>not necessary</u> to provide me with any excuses for absences (<u>unless you are absent during an examination</u> – read the previous section).

Attendance Note 1: If a pop quiz or any other assignment is given when you are absent, you CANNOT make it up, regardless of the reason for your absence (excused or unexcused).

Attendance Note 2: I will NOT reply to any emails asking what we did in class during your absence- We will follow the syllabus. If you miss class, get notes from a classmate and ask him/her if there were any announcements.

**Participation:** Your participation in this class is worth up to 4% of your grade.

Your contributions to the class discussions are highly desirable and will make class sessions more interesting. Positive participation includes responding to my questions, asking your own questions, and contributing to class discussions. All of these activities will *positively* impact your participation grade.

Negative participation includes: sleeping in class, side-talk with your neighbors, coming to class late, and any other class disruptions- any of these activities will *negatively* impact your participation grade, even if you contribute to class discussions. If you use personal electronic devices in class that will result in a pop quiz for the entire class and your removal from the classroom, and it will negatively impact your participation grade. Also, if you misbehave in class or disrupt class in any way you may be directed to leave the classroom and your participation grade will be negatively impacted.

## Your participation grade will be calculated as follows:

 Sometimes Contributes to Class Discussions: 1%
 Often Contributes to Class Discussions: 2%
 Almost Always Contributes to Class Discussions: 3%
 Always Contributes to Class Discussions: 4%

**Pop Quizzes:** These will be assigned only if anyone is found to be using an electronic device in class, and will count for a total of **2%** of your grade. Pop quizzes will be very difficult to pass. If you are *absent* when a pop quiz is given, you <u>cannot</u> make it up, irrespective of the circumstances, and will earn 0% for any quiz you miss. Pop quizzes will be graded on the basis of the content and clarity of your answers.

In-Class Writing Assignment: You will have ONE required writing assignment that is worth a total of 4% of your grade. The writing assignment will take place during class on Thursday, December 6, 2018 and requires you to write about issues that address your awareness of societal and/or civic issues, critical thinking, and communication skills. NOTE: IF YOU MISS THIS CLASS SESSION FOR ANY REASON, YOU WILL NOT BE ABLE TO MAKE UP THIS ASSIGNMENT.
