Course Objectives / Student learning Outcomes: After successful completion of this course, students will:

- Enhance their analytical understanding of microeconomics theory beyond that acquired in the Principles of Microeconomics (ECO 2302 course).
- Integrate theory and practice of microeconomics concepts applicable to challenges faced by individuals, business firms, and policy-makers.
- Integrate the use of mathematics tools, mainly algebra and differential calculus, into the analysis of microeconomics.

Course Requirements and Grading: Opportunities to Perform: Throughout the semester students will have the opportunity to earn and accumulate points up to a maximum of 400 total points as follows:

- Two exams @ 100 points each
- Final exam, non-comprehensive @ 100 points
