Course Description

Essentials of Statistics. Three semester hours. Techniques of statistical applications concerning descriptive statistics, tests of hypothesis, regression and analysis of variance. Prerequisite: One course in college mathematics.

Student Learning Outcomes

Upon successful completion of this course, students will:

1. Explain the use of data collection and statistics as tools to reach reasonable conclusions.
2. Recognize, examine and interpret the basic principles of describing and presenting data.
3. Compute and interpret empirical and theoretical probabilities using the rules of probabilities and combinatorics.
4. Explain the role of probability in statistics.
5. Examine, analyze and compare various sampling distributions for both discrete and continuous random variables.
6. Describe and compute confidence intervals.
7. Solve linear regression and correlation problems.
8. Perform hypothesis testing using statistical methods.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students need to check their e-mail regularly with the address that they have provided to the instructor for class announcements. Access to MyStatLab, a computer, and the internet will be needed for online homework assignments. Students will be required to know how to use their graphing calculator (A TI-83 or 84) on exams.

Calculator Loan Program: The Mathematics Department has set up a calculator loan program to support students. Students can borrow a calculator for a semester with a fee (\$10 to \$15 for TI-83/84). It is first come, first served basis.

Instructional Methods

You will be expected to read the text, watch a video, and complete homework problems in MyStatLab for each section covered. This is how you learn the content. You have three attempts at each homework assignment if you wish to use them to raise your grade. Multiple sections will be due on the same day. In addition, quizzes over multiple sections will be administered online.

Student Responsibilities or Tips for Success in the Course

You are expected to regularly log into the course and pace yourself throughout the week in order to have all weekly assignments done on time. Assignments completed after the due date will incur a 15% penalty. On average, you should spend about 6 – 9 hours per week working on this course in order to be successful.

Students are required to complete homework using MathXL software. Homework is due by the posted dates in D2L and in MyStatLab. It is extremely important for you to work ALL homework in order to be prepared for the exams. If you are not keeping up with the work in the course, it will most likely be obvious in your homework and test grades.

If a student experiences any technical difficulties with MyStatLab, be sure to use the online help and technical support from the software company. If a student continues to have trouble accessing or navigating the software, please contact instructor through email or come by his/her office during office hours for some individual help.

The Math Skills Center, located in Binnion 328, is open Monday and Wednesday from 8am – 8pm, Tuesday and Thursday from 8am – 6pm, and Friday from 8am – 12pm. Free tutoring is available for students who need help with their math courses. In addition, the Academic Success Center also offers supplemental instruction/tutoring for students and their hours can be found at the university web site. The Mach III/TRIO Program is available for students who qualify for additional resources, such as private tutoring. In order to qualify, students must meet certain conditions, such as being a first-generation college student. Assessments

There will be a midterm exam and a comprehensive final exam. The two exams and the final exam will be HAND-WRITTEN and must be taken on campus at the Academic Testing Center SS 308 in Commerce, TX or at the nearest approved testing center, if you live far from Commerce. You will have 2 hours for each exam. You will be responsible for scheduling a time with me to test in the Academic Testing Center (ATC) in Ferguson (Social Sciences Building Room 308) or scheduling a time directly with the nearest approved testing center (you must send information to me for approval during the first week of class). The operating hours for the ATC are Monday through Thursday 10 a.m. to 6 p.m. and Friday 10 a.m. to 3 p.m. When it is time for each of the two exams, I will tell you the “week” in which you must take the exam. You pick the day and time, email me (for the ATC) or call your approved testing center to set up your time, and then show up to take the test on paper at the testing center with your photo ID card. Please make sure you note testing center closing times to be sure you have 2 hours for the exam.
