#### **Course Description**

A broad interdisciplinary course in the historical development of the United States and North America from 1865. Note: Assignments will focus on reading, writing, and analysis. Pre/co-requisite Eng. 1301 or 1302.

#### **Student Learning Outcomes**

1. Students can explain the role of historical memory in shaping the culture and society of the American South.

2. Students demonstrate an awareness of societal and civic issues as they pertain to the history of the American South.
3. Students are able to form substantive and evidence driven arguments about historical memory to propose solutions to problems or explain phenomena.

## **COURSE REQUIREMENTS**

### **Minimal Technical Skills Needed**

Using the learning management system, using Microsoft Word and PowerPoint, and using online reading and video sites.

### **Instructional Methods**

This course will be delivered entirely online. There are videos and readings as the primary means of delivery. Other instruction will come from instructor provided resources.

### **Student Responsibilities or Tips for Success in the Course**

Students should email the instructor when they submit their work for fastest grading and response time.

Students should pay attention to which LO's each question on their pretest/posttest attempts is labeled with. That tells the student where the material they need to learn for that question is located in the course. With that information, they should prioritize studying their weaknesses to increase their score on the next assessment.

Students should submit their research paper earlier in the term. These take the instructor longer to grade than other assessments, and additional attempts after the term is over will not be given. So, to make sure they can utilize additional attempts, earlier submission is advised.

Students are expected to follow the university's academic honesty policy, and any deviation from it will result in the offending work receiving zero credit. So, students are advised to always write their responses in their own words.

## **GRADING**

Final grades in this course will be based on the following scale:

A = 90%-100%

B = 80%-89%

F = Below 80%

Students are required to pass a posttest (minimum score of 80/100) for each competency and the research paper (minimum score of 80/100) to pass the course. Students will get three attempts to pass each competency posttest and three attempts to submit their research paper. Failing one of these requirements will result in failure of the course.

Aside from posttests and the research paper, no other assessments will count toward your final grade.

### **Assessments**

All grades in this course will be on a 100 point percentage scale. For the Posttests and the Research paper, an 80 is required to pass. Assessments can include papers, essays, short answer questions, multiple choice, and true/false questions.

Each of the Learning Outcomes have their own means of assessment. The four listed are each their own competency and will be measured based on Posttest percentage for their respective competency.
