Course Description

An overview of law enforcement, courts and corrections from historical, ethical, philosophical, and practical perspectives. A focus on defining crime, searching for its causes, and studying its impact on society through the investigation and arrest of suspects, prosecution and defense of the accused, and punishment and rehabilitation of criminals.

Student Learning Outcomes

- 1. Describe the history and philosophy of the American criminal justice system.
- 2. Explain the nature and extent of crime in America.
- 3. Analyze the impact and consequences of crime.
- 4. Evaluate the development, concepts, and functions of law in the criminal justice system.
- 5. Describe the structure of contemporary federal, state, and local justice agencies and processes.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Examples include: Using the learning management system (D2L), using Microsoft Word and PowerPoint, using presentation and graphics programs, etc.

Instructional Methods

This course is in class on campus with some online assignments. In class discussion; seldom do I stand in front of the class and lecture for entire class. Attendance will be graded every class period. There will be one in class pop quiz every week, for a total of 12 quizzes; only 10 will be graded, the lowest 2 grades will be dropped. Articles for reading may be handed out in class and/or online in D2L, especially if class does not meet, refer to the syllabus. It is the student's responsibility to have the chapter read before for weekly class. There is a group project; guidelines will be handed out separately. **Project guidelines and grading rubric for course group project paper are located in doc sharing.**

Laptops are accepted in class to take notes on, if I see you are browsing on the internet I will not allow laptops. Student Responsibilities or Tips for Success in the Course

Each student should participate during class discussion, having read the chapter prior to class. Complete the online discussion when applicable. Group project work is mainly to be done outside of class, there will be a meetings in class, however, this will NOT be enough time to complete the group project. The only ignorant question is one not asked. If I don't know the answer, I will research and find the answer and we will seek answers together. You should expect to study one physical hour for each course hour you take, minimal!

IMPORTANT NOTES:

- 1) Students must cite in-text using APA style, examples in D2L or look online.
- 2) Late assignments receive a 10% deduction in points, and cannot be accepted beyond one week of the original due date.
- 3) Written assignments and/or discussion cannot be re-done or re-graded.
- 4) All written work is subject to Turnitin review. Students who plagiarize will receive a zero on the assignment in question.

GRADING

Grades will be based on two exams; Exam 1 is the midterm; Exam 2 is the final (100 points ea. =200pts); Project paper (100pts.); 12 quizzes (10 pts per question =100 total pts.; attendance/participation (6/7pts per class period =100pts).

submitted in hard copy on reading day. AND end of semester presentation/reading script, lastly you will submit a two/three page reflection paper discussing your group project process.
