Course Description: For beginning literature and languages graduate students who have not had an equivalent graduate-level course, this course covers manuscript preparation, format; research techniques for literary, linguistics, and composition/rhetoric studies.

This Semester: Students will learn the skills, methods, and methodologies of research. The main assignments consist of bibliographies, annotated bibliographies, and bibliographic essays. Students will also learn the ins and outs of MLA formatting.

Platform: This is a dual modality class. That means I have 2 sections, one of which is online, and the other is f2f. We will be recording this class and it will be available to you and to the online students. Online students will be joining us either through streaming or through material they have written through discussion boards and other outlets that I will share with you. You will need access to D2L, our online learning management system, for assignments, the grade book, discussion boards and other components reside there.

Student Learning Outcomes:

- Demonstrate the ability to compile useful bibliographies associated with academic/scholarly research
- Demonstrate the ability to write an organized, well written bibliographic essay associated with academic/scholarly research
- Demonstrate the ability to use secondary scholarship in ways that reflect the conventions associated with researched writing: summaries, paraphrase, and quotations, with clear attribution and works cited or bibliography

Course Policies

Late Papers: I seldom accept late papers, and if I do, it is at my discretion. I don't usually accept late assignments; if I do, I won't grade them until the end of the semester, I won't provide

comments, and the score will be reduced by one letter grade. Please note that incompletes are generally unavailable and are granted only under extreme situations.

Attendance: I know how very complicated life can be. Still, as graduate students, you have greater responsibilities than undergraduate students in terms of attendance and discussion in that you are demonstrating your professionalism through the classes you take and how you conduct yourself in those classes. If you miss classes, I will assume one of two things: you have other priorities or you're not taking the course seriously. As indicated above, I don't usually accept late assignments; if I do, I won't grade them until the end of the semester, I won't provide comments, and the score will be reduced by one letter grade.

Please be aware that if you cannot attend class, you'll need to make up for that through an assignment to be identified. Going online for information provided that week does not constitute being "present" in the face-2-face course.

Revision Policy: Revisions are at my discretion, but I generally encourage students to revise. Some circumstances that preclude revision:

- 1. The assignment has been turned in late
- 2. You have made an A or B on the assignment
- 3. I perceive that the mistakes are careless or a result of not spending sufficient time on the assignment
- 4. The assignment does not meet the basic requirements (incomplete, doesn't meet word count, etc.) I have established
- 5. The paper has been recycled or was not written by you. A recycled paper is one written for another class and handed in under the pretense that it was written for this class. Students are welcome to use material written for other classes, but they must first clear it with me, and I will explain what needs to be done in order for it to be acceptable.

TECHNOLOGY REQUIREMENTS

Browser support
