Course Description

In this course the theory and practice of neural computation for machine learning are introduced. Artificial neural networks are used for many real-world problems: classification, time-series prediction, regression, pattern recognition. The class starts with an introduction to feed forward neural networks. More complicated multi-layered "deep" networks are then covered. Basic backpropagation, gradient descent and modern regularization techniques are implemented in assignments. The class will look at modern deep learning techniques: convolutional neural networks, deep belief networks and deep recurrent neural models such as LSTM nets. Readings and current results from the literature on neural network research will be discussed.

Student Learning Outcomes

1. Understand intuitively the mathematical and geometrical basis of how NN work and learn.
2. Be able to use multi-layer feed forward networks to classification and regression machine learning problems.
3. Be introduced to so called deep learning neural networks and their applications.
4. Look at some of the uses and advantages of recurrent neural networks.
5. Be familiar with other types of NN architectures and their uses.

Learning outcomes will be measured through mapping assignment and test questions to specific outcome items, as well as through exit surveys of student experiences with the outcome familiarity.

Students should be proficient in a high level programming language, like C++, Python or Java.

All materials, assignments and tests will be conducted through the D2L MyLeo Online learning system.
