Course Description

This independent study will focus on building a photography portfolio to extend the student's current practice and area of interest. The independent study is designed for advanced students who have a special area of focus that does not necessarily align with an assignment driven photograph course.

At the conclusion of this course students should be able to demonstrate the following:

- A portfolio demonstrating proficiencies and craftsmanship in a specific area of interest.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

DSLR cameras exposure, Digital file management and basic principles of working with digital files for online and print format, Printing skills, Basic DSLR video capture, Audio capture, Adobe Premiere Pro, Adobe Lightroom, Adobe Photoshop.

Instructional Methods

This course will consist of a bi-monthly meetings to discuss the students progress. During the first week of class the student and professor will determine a bi-weekly meeting schedule. During the first 6 meetings, work in progress will be discussed, critiqued, and evaluated. During the final meeting, the final portfolio will be reviewed and discussed.

Projects:

Portfolio Work

Students will create photography and/or video in the specific professional direction they intend to work in. Students will present a proposal at the beginning of the semester and create well-crafted, conceptual-strong photographs or videos.
