Course Description

A study of the American Civil Rights Movement from the 1950s to the present.

Student Learning Outcomes

- A. To introduce students to the nature of the American Civil Rights Movement both as background to contemporary events and as a major force in the development of American culture.
- B. To place the struggle for African American civil rights within a general historical context in order to provide students with a perspective of the African American

- experience in the United States and the general expansion of rights which has taken place in this country.
- C. To place an understanding of the interplay of politics, economics and cultural changes by observing the manner in which alterations in one bring on changes in the others.
- D. To teach the historical method as a means of critical thinking, including the evaluation of conflicting testimony in assessing historical fact and assisting the student in applying this historical perspective to the major trends examined.

COURSE REQUIREMENTS

- 1. Complete the reading for the class to fully comprehend the importance of the material.
- 2. Be engaged and expect to learn about civil rights on the trip.
