Course Description and Objectives

This online course provides students with a rigorous introduction to the fundamental principles of business finance. The primary concepts covered include the time value of money, different interest rates, principles of valuation and risk, the nature and characteristics of domestic and international financial securities and markets. Specific applications include the valuation of debt and equity securities and capital budgeting analysis.

Prerequisites

Basic knowledge of Calculus, Statistics, and Accounting

 We will not strictly follow this textbook. There are topics in the course that somewhat deviate from the book. The textbook can be used as a further reading material, but all you need for the course is my Power Point slides, my practice questions and answers already posted, and my recorded lectures.

Exams and Grading

There will be 2 online exams during the course and one online Assessment Case. Each exam will last for 1 hour and 15 minutes. Each exam contains 12 multiple-choice questions (8.333 points each question, 100 points altogether). These relatively short exams will cover the most recent lectures, and they will be non-cumulative. Once you start an exam, you have to complete it within the allowable time. Make sure to have a fast Internet connection. Since you will take the exams online at your convenience, there will be no makeup exams. The Assessment Case will contain several multiple-choice questions as well, but it will have no time constraints.

Course Content and Communication

All communications will take place through TAMUC official website (MyLeoOnline or D2L).

Grading System

Your final grade will be based on a simple average of the two exams and the Assessment Case during the course (with equal weight of 1/3 to each thing). Once this average is computed, I will assign a final grade according to: 'A' (from 90 to 100), 'B' (from 80 to 90), 'C' (from 70 to 80), 'D' (from 60 to 70), 'F' (less than 60). *There will be no more optional bonus points or mercy assignments, so make sure to do your best on these tasks! I do preserve the right, however, to curve up (never down) grades whenever necessary.*

 We will use a lot of calculus and statistical methods during the course. I will attempt to clarify these techniques when it is relevant, yet I can only do that concisely. Make sure to refresh your memory with those techniques. The best time to do that is yesterday!

Attendance and general behavior

This is an online course and students must have high self-discipline. It is your responsibility to listen to the online lectures (available throughout the entire semester), to download / print the Power Point presentations and the practice questions and answers, and to take as many notes as you can. If you have additional questions, catch my attention right away (likely through email), but please don't wait until the last moment before the exams.

In addition, current anti-virus software and supporting tools such as Adobe Reader and Adobe Flash Player should be installed and kept up to date. Finally, you should enable popups.

Microsoft Word is the standard word processing software, Microsoft Excel is the standard spreadsheet software, and Microsoft PowerPoint is the standard presentation software.
