COURSE DESCRIPTION AND OUTCOMES:

Students will become acquainted with the general historical development of art from the prehistoric period through the medieval period. We will explore art and artifact contextually – through culture, language, politics, and location, as well as techniques and production, to better begin to truly see and understand what makes this work so essential. Addressing the way our identity informs our view of art, through our exploration of various cultures and art we can hopefully broaden our horizons and begin to explore ant-racist ideology. Readings, museum/gallery assignments, films, class discussion, slide lectures, videos, and essay exams will all be incorporated throughout the semester. This class will require students to *memorize* a number of images that represent the historical span of the course and to *demonstrate the analytical skills* necessary to communicate visual information. By the end of the course you should not only be able to discuss historically significant works of art, but also be acquainted with the characteristic features of the art and culture of each period from the prehistoric age to the gothic era.

COURSE OBJECTIVES:

- become acquainted with the characteristic features of the art and culture of each period from the prehistoric age to the medieval era
- define and utilize important art and art historical terminology
- discuss and explain historically significant works of art
- analyze significant styles and movements within art history and including a variety of types of media
- enhance visual literacy and critical thinking skills
- communicate your views and interpretations to others, gaining insight into broader perspectives
- analyze the relationships among content, context, and style in Western and Nonwestern Art
- relate art history to broader life experiences and the contemporary world

ASSESSMENT:

Students' ability to meet the course objectives and learning outcomes will be evaluated through written assignments, discussion board posting, worksheets, projects, and essay questions.

WORKLOAD:

The rule of thumb for time required for course study and preparation each week for a face-to-face class or an online course during the spring and fall semesters is three times the number of credit hours (or 9 hours per week) for the course. If you find yourself unable to complete course requirements in a timely manner, refer to the University's withdrawal policy and the appropriate dates. Incomplete grades are only granted for extreme emergencies. Being "overloaded" either from other class assignments or job commitments are not considered to be emergency situations.

COURSE REQUIREMENTS (subject to change)

Participation: Each person is expected to be prepared for the class, which means having completed the reading and/or viewing the film screening and completed the assignments. Responding to the discussion prompts and commenting on peers' posts is a pivotal and key part participation.

Worksheets: Throughout the class we will have multiple kinds of worksheets, all of which are worth ten points each. These will be specific to material covered in the course, and will be based on videos, websites, readings, etc.

Discussion: Each student will write numerous times to the discussion page for the class. There will be clear class prompts, with word counts for you to follow.

Projects: For each section of the course, there will be a project exploring a larger topic. These will differ by section, and will engage different types of writing including book reviews, architectural investigations, etc,

Assignments will NOT be accepted over one week late. If turned in late, the grade will be reduced by one point.

NO EXTRA CREDIT WILL BE ASSIGNED

FORMATTING POLICY: All written assignments must be typed using the following guidelines: 12 pt. Times New Roman font, 1" margins, double-spaced, with page numbers. Failure to format properly will result in a lower grade.

EMAIL POLICY: For all emails sent, please **include full name, student ID, and the class** that you are attending (this is a school policy). Do not send emails to myself and other professors at once, as each professor has different issues to address.

HANDING IN ASSIGNMENTS

Each assignment must be uploaded on time. For each class day late, the grade will be deducted one letter grade. **Assignments will NOT be accepted over ONE week late.**
