Course Description

The study of financial theories and practical application as they impact sport revenues and expenditures; familiarization with current issues and trends in financing sport organizations.

Course Objectives

At the end of this course the students will be able to:

- Describe the current financial status of diverse segments of the sport industry.
- Demonstrate the ability to analyze and problem-solve various cases relating to financial management in sport.
- Understand the application of financial analyses and forecasts to sport organizations.
- Demonstrate appropriate skills with spreadsheets for budgeting and managing financial resources.
- Understand fund-raising strategies used to generate revenues for sport enterprises.

Course Requirements

Please note that all assignments **must be typed**, a 1-inch margin on all sides, double-spaced in 12-point font (in Arial, Cambria, Calibri or Times New Roman only). Please use APA 6th Edition (American Psychological Association).

Revenue/Valuation Report (300 points)

Students will choose one franchise or athletics department and develop an extensive report (at least 8 pages) analyzing revenue streams, income, expenditure, and, where possible, financial management. Attendance, merchandise demand and supply, concession suppliers, etc. should also be considered. Make sure to draw from academic theory to underpin your work.

Current Issue Report (300 points)

Students will imagine being an Athletics Director at two 'types' of institution (e.g. DI and DII; DII and DII; DII and high school; etc.) and consider how the current COVID-19 crisis has impacted on the financial status and security of those institutions – you are welcome to use actual examples if you wish (e.g. BGSU cutting baseball, etc.). Make sure to draw from academic theory to underpin your work.

Discussion Posts (50 points each x 4 = 200 points)

Students will participate in discussions posted in myLeo. A question will be posted on the discussion forum of myLeo based on class reading. Follow guidelines on posts to earn maximum points.
