Course Description

Government 2306 is a broad interdisciplinary course in the development of the Institutions and Policies of the Federal Government and the State of Texas. In addition to developing critical thinking skills, this course is designed to give you an understanding of the interaction between circumstance and institutions by which the American experiment in self-government with justice occurs.

Student Learning Outcomes:

1. Explain the origin and development of the Texas constitution.
2. Describe state and local political systems and their relationship with the federal government.

3. Describe separation of powers and checks and balances in both theory and practice in Texas.
4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government.
5. Evaluate the role of public opinion, interest groups, and political parties in Texas.
6. Analyze the state and local election process.
7. Identify the rights and responsibilities of citizens.
8. Analyze issues, policies and political culture of Texas.

Instructional/ Methods/ Assessments

The reading assignments and class sessions are listed for each week. I expect you to complete the reading prior to class and be **PREPARED** to discuss or address specific issues raised in the readings. Written assignments will be submitted at the beginning of the class period to the instructor.

Assignment Explanations

Reading Assignments:

The reading assignments and class sessions are listed for each day. I expect you to complete the readings prior to class and be **PREPARED** to discuss and address specific issues raised in the readings. Written assignments will be submitted to the instructor at the beginning of the class period. The material covered in the assigned readings can be on the exam even if the information not covered in class. READ the assigned readings.

Daily/Weekly Discussion:

Each student is required to participate in weekly discussions. As this is a summer class you will be required to participate in four (4) discussion posts per week. You will be required to submit one original post and respond to two of your classmates. In order to respond you must first create your original post.

Legislation Project Part I: You will track two different pieces of legislation as they travel through the US Congress. You will prepare an informal presentation for the class on each. You will be the expert concerning this legislation and should be about to explain why the legislation is necessary, who sponsored it, has the legislation met resistance, and what is the expectation of the legislation being passed.

Part II: You will contact a governmental representative concerning the bills you have researched and explain your position on the topic. You may choose to write your personal representative or a sponsoring representative. You may also contact a NGO who would be interested in the legislation. You will submit a copy of your written work to the NGO or representative as part of your grade.

If you do not participate, you will not pass the class!
