Anatomy, physiology, nutrition, genetics and health of companion animals including cats, dogs, rabbits, rats, mice, reptiles, amphibians and fish. Problem solving and enterprise management.

- 4. Student progress will be evaluated by quizzes, exams, and online discussions over class content.

#### Assessments

A discussion topic will be prompted every Sunday. Each student will be responsible for responding to the initial discussion prompt and then responding to at least 1 other students posts. These posts need to be thought out and exhibit critical thinking and meet all points listed within the initial discussion prompt to receive full credit. All posts and

replies to posts need to be professional. Unprofessional and rude behavior will not be tolerated.

The final exam will be comprehensive and due by 7/2/2019 at 11 pm. It will cover all material that was provided through the PowerPoint lecture materials.
