Course Description

This course is designed to introduce business analytics programming in Python to students. Students will learn programming foundations, application development in Python, and how to integrate Python applications with business operations in this class.

In the past a couple of years, Enterprise ranging from startup companies to Fortune 100 companies are quickly moved to cloud-based analytics environment. To prepare students to be better positioned in this new change, we will use the free cloud-based big data platform provided by the Databricks Community Edition (<https://databricks.com/product/faq/community-edition>).
