COURSE INFORMATION

Materials – textbooks, readings, supplemental textbooks: Students will choose scenes from film or television scripts to perform in front of a camera.

Optional Readings:

The Science and Art of Acting for the Camera: A Practical Approach to Film, Television, and Commercial Acting by John Howard Swain Secrets of Screen Acting 3rd Edition by Patrick Tucker Looking at Movies by Richard Barsam and Dave Monahan

Course Description:

This course will define the differences between film, television and stage acting, as well as other aspects of the business of acting. You will be given scenes from film and television to rehearse and self-record your performance. You will also learn the basics of film production so you can create professional self-taped auditions. This course will also explain how to analyze the form, content, and meanings of movies.

Student Learning Outcomes:

By the end of course, every student with a passing grade will be able to:

- 1. Demonstrate what an actor does when acting for film or TV.
- 2. Demonstrate a knowledge of words or phrases that you may hear on a shoot.
- 3. Demonstrate an ability to analyze a film/TV scene.
- 4. Demonstrate a knowledge of the business of acting.
- 5. Demonstrate knowledge in these concepts by self-taping regularly.

6. Demonstrate proficiency in accepting and incorporating constructive criticism into your own performances, while developing the skills needed to humanely and insightfully evaluate both personal artistic efforts and the work of others.



Course Objectives:

- 1. To introduce and develop skills and techniques for on-camera performance.
- 2. To develop a basic understanding of the on-camera production process.
- 3. To develop critical on-camera audition and performance evaluation skills.
- 4. To develop a basic understanding of the business of acting.
- 5. To begin looking at movies analytically and perceptively

COURSE REQUIREMENTS

Instructional / Methods / Activities Assessments Assignments:

1. Quizzes and Final - (40%)

There will be three quizzes and one final. They will be multiple choice, T/F and short answer.

2. Performance Response – (5%)

You will be required to write ONE type written paper that identifies the presence or absence of the basic acting tenets outlined in class and what affect those elements had on the acting performance from a movie or TV show.

3. Reflection - (10%) - Write a one to two page reflection on how you've grown and what you've learned from your self-taping experiences.

4. Headshot/Resume - (5%)

You will also be required to create a professional resume listing your education, training and acting experience. You will demonstrate what elements make a good headshot in brief essay attached to your resume.

5. The Business of Acting: an informative paper - (10%)

You will be required to write a one and a half to two page type written paper that demonstrates your knowledge of resources helpful to building an actor's career. In this paper you will discuss websites, agents/managers, casting directors and type and branding.

6. Self-taped scenes: (30%)

Prepare one speech or scene from a TV/film script, 30 seconds 60 seconds. You can have an off camera reader with you while shooting this. (Do not write it yourself.) Memorize it and be ready to shoot the FIRST DAY of class.

Grading

Grades will represent levels of achievement.

- 2. Performance Responses (5%)
- 3. Reflection (10%)



- 4. Headshot/resume (5%)
- 5. The Business of Acting paper (10%)
- 6. Self-taped acting scenes (30%)

These are all offenses that warrant disciplinary action up to, and including, an F in the course. Additionally, any student found guilty of a Breach of Conduct, including Academic Honest, could face the following disciplinary actions imposed by the University:
