Course Description

World History differs from traditional Western Civilization not only in its greater geographic scale but also its longer chronological scope. This course begins with the earliest human

tribal organizations. Consideration of the ancient period will also include the development of cradles of civilization, the growth and decline of classical cultures, interactions among classical and nomadic peoples, and the establishment of great world religions. The study of the medieval period will include varieties of rebuilding after the collapse of classical empires, the roles played by great world religions in medieval cultures, and the development of technologies of communication and transportation. Prerequisites: Nonmajors may enroll with consent of department.

Student Learning Outcomes

- 1. Students will be able to form substantive and evidence-driven arguments to propose solutions to problems or explain phenomena.
- 2. Student communication will follow conventions of grammar and syntax appropriate to the audience, purpose, and message.
- 3. Students will demonstrate awareness of societal and/or civic issues.
- 4. Students will be able to understand their role in their own education.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students must possess the skills necessary to update and utilize reliable computer and internet access. Access to an alternate location (TAMUC Gee Library, local public library, etc) in the event of technical difficulties. It is recommended that students acquire a local library card now so you are prepared for the semester if you are a remote student and do not have access to Gee Library. Students need to be familiar with Microsoft Office and navigating Brightspace.

Instructional Methods

Participation in online group discussions, reading quizzes online using writing assignments, and exams are utilized to help students learn to recognize and summarize primary sources. With that in mind, students will explore the historical causes and their effects world history to the 17th century. Methods used in this course are primarily reading and writing about these events. Each student will learn from assignments how to effectively identify and communicate the central argument of the materials and construct college level responses.

INTEGRAL TO THE INSTRUCTIONAL METHODS UTILIZED; READ AND ADHERE TO THE FOLLOWING POLICY:

Online courses offer a chance for developing a rich learning community where wonderfully diverse people from a kaleidoscope of backgrounds come together to share and learn from one another. Respecting the opinions of others and allowing for a safe space to explore the events of history is paramount to learning in such a platform.

Students should expect to encounter differing opinions and multiple perspectives. Respectful, healthy discussions that utilize evidence to support discussions with multiple viewpoints are the beauty of such a course as this. However, aggressive or hostile language directed at anyone in the learning community will not be tolerated and will be reported to necessary University entities. Rest assured that appropriate measures will be taken to protect the safe learning space were all are welcome and included. Thank you in advance for remembering that an online class platform is nothing like other social media sites and usual classroom discussions are expected with all assignments.

Student Responsibilities and Tips for Success in the Course

As this is fully online course, it is strongly suggested that students spend the first few days familiarizing themselves with the structure of the course and the online components. Students enjoy a higher degree of success as online learners when deadlines, details, and requirements are observed. It is strongly recommended that students print off a copy of the syllabus and refer to it daily. Likewise, it is recommended that important dates and deadlines are recorded in a calendar, set alarms/alerts on mobile devises, or personal calendar, especially the last section of the syllabus which is titled: "COURSE OUTLINE/CALENDAR."

Assessments

There will be **two (2) exams** over the course of the semester. The exams will be a combination of multiple choice, short answer, and essay questions. Information regarding

the content of the exams will be covered the week before the exam. Exams will be on MyLeo D2L learning platform.

<u>Two (2) Early World Discussions</u> will be required and will deal with material covered up through the midterm exam.

One writing assignment titled <u>Comparative Analysis Paper</u> that will be a topic of the student's choosing based on a list offered by the instructor. Details regarding this assignment can be found in Assignments section of MyLeo and more instructions are provided on the Announcement section of D2L Brightspace. Students will turn in the Comparative Analysis Paper to D2L.

Four (4) Multipart Book Reviews will be turned in dealing with the two monographs assigned to the class. These reviews will be turned over the course of a two-week period using themes provided by the instructor. Instructions are found in MyLeo, including formats and requirements.
