<u>Course Description</u>: The objective of this course is to provide students with an overview of our past and present correctional system, the evolving manner in which inmates have been treated, and the controversies which still remain in the corrections system today. Students will be expected to utilize critical thinking skills to participate in discussions, and to contribute their opinions and thoughts to the class. By the end of the semester, students should be more

knowledgeable about the corrections system and its participants, as well as be aware of the different perspectives of various members of society.

#### **Course Objectives:**

- > Understand the variety of ways society punishes people who break criminal laws
- Identify the theoretical underpinnings of correctional systems and understand how correctional practices are shaped by these theories
- Explain the benefits, drawbacks and competing considerations involved in different correctional methods
- Think critically about our correctional practices and develop informed ideas about how our justice system should respond to people who break the law

## **Instructional Methods**

The method of instruction for this course will be a combination of power point presentations, discussions, and group activities. The specific activities used to engage students in mastering chapter material will be discussion board participation, four unit exams and a research Power Point as assigned.

There will be 17 discussion boards at 20 points each if completed correctly. There are 4 exams at 100 a piece if done correctly. There are also 200 points for your Power Point Final. If you had perfect scores on each that would add up to 940. The scale above will help you keep up with your grade.

#### Assessments

Exams: You will have 4 exams during the course (each exam is worth 100 points). The exams, in general, will not be cumulative, however some of the material presented later in the course builds on topics previously discussed. Exams are to be taken on the dates listed on the syllabus. You may prepare for these exams by reviewing reading assignments, class notes and discussion guestions. Each examination will consist of T/F, MC and short essay questions. Please know that a short essay is not 1-3 sentences. It is a paragraph using examples to help you answer the questions. Your examples can be something in the news today or something you look up. You should also cite any sources used to answer these questions. The short essay questions are worth 20 points each. The T/F and MC questions are worth 2 points each and will automatically grade, however the essay questions will be manually graded. So after you answer the auto-graded questions, please understand there is a total of 40 points still out there for me to be manually graded. Once graded I will add the amount of points earned to your existing total for the final grade. I will do that ASAP, just remember I have 80 students (two courses) to grade. Your exams will be available for you to take for the whole week in an effort for everyone to have the chance to take their time. Please do not leave it until 10 pm Sunday night. Use the time during the week to take the exam. Your exams are timed, but you will have plenty of time to compete them. If you have any questions about the exams, please ask ASAP, so we can fix the issue. Please note anything on your schedule in red is related to your exams.

Online Discussions: We are going to integrate most of our learning into online discussion. Please, make sure you are familiar with all aspects of D2L. There is an online tutorial if there is something you do not understand. Not understanding D2L is not an acceptable excuse for late assignments. Start now getting familiar with it. For full credit of 20 points, you will need to post an original post that is cited correctly (APA) and answer TWO of your classmates with a reply which

consists of more than "I agree or I disagree". Please also use at least a paragraph to answer your two classmates and again, please use examples to help everyone understand your answer better. Please note anything in blue on your schedule is discussion board related.

Power Point Presentation Final: The Power Point presentation will be your final which will be due at the end of the semester. The topic will be The Death Penalty. It needs to be at least 20 slides long not to include your title slide and your citation slides. In this presentation, you must take a side either, for or against the Death Penalty. It does not even have to be the way you feel, however for this final you must take a stance either "For" or "Against" the death penalty. You will need to include any information (past or present criminal cases, statistics, religious views, political reasoning, etc....) your analysis of any course related information. You will be asked to turn in via email what your stance will be and your plan on how to back that up by Week SIX. Please, use APA format writing style for this presentation. Please use color, pictures diagrams- whatever you believe looks the best to help me fully understand. I love cleverness and humor, although this is not a humorous topic, there might be places you could use humor. The more time you spend on it, the higher grade you will receive. This will be your final exam as well. Please note anything in purple on your schedule is **Power Point related.** 

You are encouraged to monitor your grades throughout the semester via the grade book in D2L. If you turn in an assignment and do not receive a grade or have a question about the grading, I need to know immediately. I will not entertain any disputes later than one week after the grades are posted. I know we are still learning the new D2L system so if you have a question, please get help! Believe me, I understand!
