COURSE INFORMATION

Course Description

Designed to introduce the students to the principles and functions of the government of the United States, this course examines the principles underlying the development of the U.S. Constitution, and the opportunities and constraints imposed by and on the political system in the U.S. Topics will include the legislative, executive, and judicial branches. Federal bureaucratic agencies, federalism, political participation, national election process, public policy, and civil liberties and civil rights. In addition, the global forces that continue to shape our understanding of the relationship between the people and government will be addressed.

Student Learning Outcomes (Should be measurable; observable)

- 1. **Critical Thinking**: Students will be able to differentiate between fact and opinion.
- Communication: Student communication will be clear, purposeful, and make appropriate use of evidence, data and technology as applicable. In written, oral, and or/visual communication A&M-Commerce students will communicate in a manner appropriate to audience and occasion, with an evident message and organizational structure
- 3. Personal Responsibility: Students will understand and practice academic honesty.
- 4. **Social Responsibility**: Students will demonstrate an understanding of societal and/or civic issues.

- 3. Describe separation of powers and checks and balances in both theory and practice (Social Responsibility).
- 4. Demonstrate knowledge of the legislative, executive, and judicial branches of the federal government. (Communication, Personal Responsibility).
- 5. Evaluate the role of public opinion, interest groups, and political parties in the political system. (Critical Thinking, Personal Responsibility).
- 6. Analyze the election process. (Critical Thinking).
- 7. Describe the rights and responsibilities of citizens. (Personal Responsibility, Social Responsibility).
- 8. Analyze issues and policies in U.S. politics. (Critical Thinking, Social Responsibility).
