Course Description

HIST 1302—History of the United States from 1865
A broad interdisciplinary course in the historical development of the United States and North America from 1865. Note: Assignments will be focused on reading, writing, and analysis. Prerequisites: ENG 1301 or concurrent enrollment or ENG 1302 or concurrent enrollment.

EXAMS

There will be two exams, a mid-term and a final. You may use your notes or textbooks during the exams. The tests will include multiple choice questions, short answer questions, and one short essay question.

ONLINE QUIZZES

There will be ten quizzes throughout the semester. These will cover material in the lectures, in the readings, and in the video assignments for each week. The Quizzes will be posted on D2L on Sundays and will be due by Saturday (at midnight) of each week. They are open book, and open note, and are intended to demonstrate that you have read/watched the outside assignments, AND that you understand the material. The questions will ask for facts AND a personal analysis of facts (your opinion).

PARTICIPATION GRADE

The Participation Grade is based on

1. Attendance- both in-person and online options will be available.
2. Class Participation & Engagement

This grade will be assessed throughout the semester. Show up, speak up, and be brave! Plan to be an active member of the class.

OFFICE VISIT QUIZ

BOOK REVIEW

A 2-4 page paper will be due on November 6, covering *Double Victory: A Multicultural History of America in World War II*, by Ronald Takaki. We will discuss this in detail the second week of class. There will also be a review handout to accompany the discussion. The paper will be submitted through TurnItIn. Plagiarized or copied papers will result in an automatic FAIL in the course.
