Course Description

The study of the nature extent, causation, treatment, and prevention of Juvenile Delinquency.

- 1. Apply a sociological and criminal justice perspective on juvenile delinquency to the causation, nature and extent of delinquency, the juvenile court, and possible control, treatment and prevention strategies;
- 2. Make a general sociological analyses of specific types of delinquency and juvenile offenders:
- 3. Provide a brief overview pf the Texas Juvenile Code and the Juvenile Justice System in Texas; compare/contrast it with other states;
- 4. Apply critical thinking skills to the problem of delinquency and express their ideas in written and oral communication;
- 5. Use critical thinking skills to assess current trends in juvenile delinquency and develop a plan with policy implications for "rethinking" the problem of delinquency

COURSE REQUIREMENTS

Instructional Methods

The method of instruction for this course will be a combination of power point presentations, discussions, and group activities. The specific activities used to engage students in mastering chapter material will be discussion board participation, classroom THREE exams and a research paper as assigned.

Assessments

Exams: You will have 4 exams during the course (each exam is worth 100 points). The exams, in general, will not be cumulative, however some of the material presented later in the course builds on topics previously discussed. Exams are to be taken on the date listed on the syllabus. Each examination will consist of short essay questions. You may prepare for these exams by reviewing reading assignments, class notes and discussion questions. Please know that a short essay is not 1-3 sentences. It is a well thought out answer in 2-3 good paragraphs. You should also cite any sources used to answer these questions. Please note anything on your schedule in red is related to your exams.

Online Discussions: We are going to integrate some of our learning into online discussion. Please, make sure you are familiar with all aspects of D2L. There is an online tutorial if there is something you do not understand. Not understanding D2L is not an acceptable excuse for late assignments. Start now getting familiar with it. For full credit of 20 points, you will need to post an original post that is cited correctly (APA) and answer TWO of your classmates with a reply which consists of more than "I agree or I disagree" Please note anything in blue on your schedule is discussion board related.

Research Paper: The research paper will be a formal research paper due at the end of the semester. It is not to be an argumentative or opinion paper, but a research paper. This paper must be written based on a discussion and analysis of a course related (juvenile delinquency) issue. Please, use APA format writing style for this paper. The paper will be a minimum of 8 pages long NOT to include the title page nor the reference page. You will have deadlines to meet throughout the course with reference to this research paper. This will be your final exam as well. Please note anything in purple on your schedule is research paper related.

Reading Assignments: You will have reading assignments throughout the semester. You are assigned chapters to read prior to class so you will be able to participate in class discussions and assignments. Please note that anything in Orange is Reading Assignment related.

You are encouraged to monitor your grades throughout the semester via the grade book in D2L. If you turn in an assignment and do not receive a grade or have a question about the grading, I need to know immediately. I will not entertain any disputes later than one week after the grades are posted. I know we are all learning the new D2L system so if you have a question, please get help! Believe me, I understand!
