Course Description

COURSE REQUIREMENTS

You must have access to strong, reliable internet for this course. We will be meeting virtually and will complete in class assignments daily. This requires reliable internet. Our textbook is an online resource and you will need to be able to access it on a regular basis.

Minimal Technical Skills Needed

- Ability to navigate D2L Brightspace and complete assignments online
- Ability to use Microsoft Word, or similar programs, to complete the midterm and final essay assignments.

Instructional Methods

This class is lecture based. All assignments will be online and will be based on lecture materials, the textbook, and assigned supplementary readings such as short primary source documents and articles.

Student Responsibilities or Tips for Success in the Course

It is the student's responsibility to complete all readings and assignments by the stated due dates. Students are responsible for attending class every class session and actively participating with the class by completing the Participation assignments and Historical Engagement assignments in class. It is the student's responsibility to inform the instructor if they are experiencing a technical issue when submitting a major assignment, or if they can not make it to class for a university approved reason.

Assessments

As you move through the course materials (the history under study), you will have several ways to interact with the materials, instructor, and your fellow students through a variety of assignments. (The Instructor reserves the right to adjust the number of assignments as the semester progresses) There are five categories of assignments:

- Quizzes- 20%
 - Quizzes will be mostly multiple choice and will be scattered throughout the semester. All quizzes will be online and are marked on the course schedule. The lowest quiz grade will be dropped.
- Participation Assignments-10%
 - There will be a variety of daily "participation assignments." These will include; short answer and multiple-choice questions, as well as surveys and active class participation. These are all in-class assignments that are used to help measure attendance and active participation with the lectures. These assignments cannot be made up if missed. The lowest three grades for this section will be dropped.
- Critical Thinking- 10%
 - These assignments are designed to prepare you to think historically and critically, as well as to help you understand the historical process. These assignments are critical to your preparation for later writing assignments.
- Historical Engagement Exercises- 20%
 - Each week there will be an online folder with supplemental reading assignments for the week, historical engagement assignments will be based on this material. These will include; primary source activities, reaction papers, discussion boards, and other activities. These assignments are designed to actively engage the students with the material, enhance analytical and critical thinking, and encourage class participation and attendance.

- Exams- 40%
 - The Mid-Term Essay is an open-book, open-note essay. It is worth 20% of your final grade. This essay will require both secondary and primary sources and the use of proper Chicago/Turabian style footnote citations.
 - The <u>Final Comprehensive Essay</u> is the open-book, open-note essay. It is worth 20% of your semester grade. This essay will require both secondary and primary sources and the use of proper Chicago/Turabian style footnote citations.
 - Both exams are to be turned in via Turnitin. Emailed submissions will not be accepted.
