Course Description: "This course will provide opportunities for students to develop and broaden their familiarity with, and understanding of Rock and Roll and other forms of American popular music. Students will be guided through outside reading assignments, class discussion, aural/visual experiences, and written assignments to allow for an increased understanding of American popular music, its heritage, and its social and historical context."

Course Objectives: Trace the historical origins of Rock Music. Describe the stylistic characteristics and aurally identify the artists and major innovations of each period. Describe relationships between the musicians and corresponding historical, social and artistic trends. The ability to read and analyze music are not requirements for this course (although prior experience may be helpful) but you will be required to develop elementary listening skills as the course progresses. Musical terminology is listed for each chapter in the student resources and is also important to fully understand the assigned readings and to help comprehend the lecture presentations. It cannot be emphasized too strongly that this is a listening class as well as a reading class and that familiarity with the works, composers(songwriters) and performers under discussion is essential. "Active" listening to the music under discussion is a must!

## **Assignment descriptions:**

Lecture Writing: Each week you will have 1-2 lectures to watch, there will be an assignment based on the lecture. We will learn how to complete the assignment in the first 2 weeks. In each lecture I will ask that you listen to a specific song and describe it in 6 music catagories: melody, harmony, rhythm, texture, form, and lyrics. Try to write something in each category to describe the music. Must be written in a complete sentence.

Documentary/Concert review Assignments: There are 6 documentaries with first person interviews that I find enhances this course greatly. All are available online and will be assigned in a weekly fashion as needed. There will be a fill in the blank follow along assignment for each.

There will also be one concert review assignment where you will view a video of a live concert and then write a review based on your knowledge of musical elements, terminology and experiences from earlier class projects. Standard margins and 12point font apply and the length will be approximately 2.5-3 pages double spaced in complete sentences with correct grammar.

Tests: For the online version of this class I will use 7-8 tests, one every 2 weeks. They are open book, open note, and multiple choice.

Final Project: Topic will not be announced until after midsemester so that you have absorbed enough material to be able to write appropriately.
