## **Course Description**

In this course we will be exploring the evolution of fashion in nonwestern countries. How they developed before and after colonizing influence. We will look at the question of cultural appropriation and how to look and when it applies.

- 1. Understand how concepts of fashion develop
- 2. Identify various nonwestern styles of dress
- 3. Learn where and how to research other cultures textile influences
- 4. Begin to understand and learn how to begin to identify the difference between cultural influence and cultural appropriation.
