### **COURSE REQUIREMENTS**

### **Minimal Technical Skills Needed**

Students must use the D2L learning system to upload assignments, track their progress, access course resource materials, and monitor their course grades. All students need to have a familiarity with the Microsoft Office Suite, or some other form of word processing program, and Microsoft PowerPoint, or some type of presentation software compatible with Microsoft PowerPoint, to download course lectures and create presentations.

#### **Instructional Methods**

Course instruction will be delivered using zoom during regularly scheduled course times. Lectures, small group discussion, student presentations and videos could be incorporated to support the learning styles of all students.

#### **Assessments**

**Required Reading**: All students will be required to read and to discuss the assigned books. The books are available for purchase at the campus bookstore, internet websites (Amazon), and at a variety of regional retailers.

**TURNITIN.COM**: All typed assignments, exams, papers, and reviews must be uploaded to the appropriate listing of the course's dropbox. Each assignment dropbox automatically uploads the work to turnitin.com for plagiarism checking. This is a requirement for the course, and the students will not receive a grade until they have completed this process.

#### **Writing Assignments**

All writing assignments must be typed in 12 pt. New Times Roman font, doubled spaced, stapled and paginated with a 1" margin. Additionally, all assignments must include, on the first page, your name, assignment, my name, course number, and date. Students must submit an electronic copy to dropbox that turnitin.com can analyze and a paper copy to the instructor. If the student does not do both, the assignment will not be graded, and the student will receive a zero. Writing assignment instructions are located in Doc Sharing.

### **Attendance**

Although the class meeting will be via zoom, my expectation is that all students will attend and participate in class.

### **Essays**

Students are required to complete several different types of essays. The essay due dated are listed in the course outline. Students must submit an electronic copy to the D2L dropbox that Turnitin can analyze. Guides for each paper are posted in D2L.

## **Student Presentation**

All students are required to make a class presentation based on the WPA Slave Narrative Project focused on Building A Free Community: African American Community Development in Northeast Texas. Each presentation should include: a brief statement regarding the historical relevance of the topic, a statement of the research question, an analysis of the relevant historical interpretations of the topic, a discussion of the relevant secondary sources. Additionally, all presentations must include a PowerPoint presentation and meet presentation guidelines to receive full credit. The presentations will last approximately 7-10 minutes. Presentation paper guidelines will be posted in D2L in the Course Resources tab.

## **Late Submissions**

All students are required to submit their assignment to the class dropbox and provide a hard copy on the day the assignment is due to the professor. For the book reviews and reception report, there will be a five-point penalty for each day the assignment is late. For the paper proposal and final paper, there is a ten-point penalty for each the day the assignment is late. The assignment is not complete unless the student has submitted an electronic copy to the dropbox and a hard copy to the professor.
